Eligibility:

Candidates with Master's degree in concerned/related subjects from a recognized University with OGPA of 6.50/10.00, 3.25/5.00, 2.6/4.00 are eligible for admission to the Doctoral programmes under General/OBC/UPS category. SC/ST/PC category candidates with OGPA of 5.50/10.00, 2.75/5.00, 2.20/4.00 in the Master's degree shall be eligible for admission. In case where Grade Points are not awarded, only marks are awarded, the candidates must have secured at least 60% marks for General/OBC/UPS category and 50% marks for SC/ST/PC category. For in-service candidates also, qualifications remain same for respective categories.

How to apply:

- The application on white paper (A4) as per appended **APPLICATION FORMAT (Appendix – I)** along with self attested copies of certificates, mark sheets, age proof certificate, domicile certificate, OBC/Caste/ Tribe/ Physically challenged certificate (if required) and non-refundable fee of **Rs. 1500/- (Rupees one thousand five hundred)** only for General/OBC/In-service candidates and **Rs. 750/- (Rupees seven hundred fifty)** only for SC/ST/PC candidates in the form of **IPO for Demand Draft** drawn in favour of the **Comptroller, Central Agricultural University, Imphal payable at the SBI (Main Branch), Imphal** should be sent so as to reach the Office of the **Registrar, Central Agricultural University, Lamphelpat, Imphal – 795004, Manipur** on or before **15th July, 2017.** (University will not be responsible for any **POSTAL DELAY**).

2. The candidates should also fill up the Admit Card in the given format (Appendix – II).
3. **Personal Interview will be held at College of Post Graduate Studies, Barapani, Meghalaya on 22nd July, 2017 (Saturday).**
4. **Date of Registration/Admission and Commencement of session is 1st & 2nd August, 2017 respectively.**
5. Candidates from Govt. Departments/SAUs and other Organizations are required to submit his/her application through the concerned Head of the Institution/Department/ Organization, failing which the candidature will not be considered.


General Notes:

The candidates who have appeared in the Master's degree examination in the year 2017 are also eligible to apply provisionally for admission but they will have to **submit documentary proof of their successful completion of qualifying degree examination on the date of registration.**

Intimation for appearing in the Entrance Examination will be sent to the concerned candidates (after 15th July, 2017) by **e-mail only. Hence, e-mail address is mandatory along with telephone/mobile numbers.** Candidates may also collect their **Admit Card personally** from the Academic Section of the University Hqtrs./College of Post-Graduate Studies, Barapani, Meghalaya where Entrance Test shall be held (**only after 15th July, 2017**).

Reservation: 15%, 7.5%, 27% and 3% seats will be reserved for SC, ST, OBC and PC as per the guidelines of Govt. of India. The reservation between SC and ST is interchangeable i.e. if sufficient numbers of candidates are not available to fill up the seats reserved for SC candidates, seat(s) can be filled up from among suitable ST candidate and vice-versa. If the University does not find the candidate from OBC category, the OBC seats shall be converted into General Category seats.

The candidates seeking admission for Ph.D. programmes in this University as sponsored candidates should be on deputation terms/study leave.




